Stakeholder Comments – Summary

- Two sets of written submissions were received following the Technical Panel vote to post on the market rule amendments for the Market and System Operations & Calculation Engines batches
- Total of 30 comments from Vlad Urukov (OPG) and Jennifer Jayapalan (Workbench Energy)
- A document containing all stakeholder feedback and corresponding IESO responses has been provided to the Technical Panel

Stakeholder Comments – Summary *(continued)*

- Several clarification questions that have been addressed with explanations or confirmations
- A number of questions on provisions resulting in relatively minor changes to the draft (e.g., clarifying the application of market suspension provisions)
- A few minor editorial comments (e.g., application of defined terms such as publication, MMCP and MORP, italics, consistency of references to the DAM and real-time market within two comparable sections, etc.)
- A few requests on market rule clarification/interpretations on historical language not significantly changed by MRP
- Concern raised regarding an electricity storage resource's inability to submit an energy bid and offer in the same hour the resource has offered operating reserve

Outcome of Responses - Summary

The responses to stakeholder comments fall into the following categories:

Response Type	Number of Responses (30)
Clarification via Response	18
Modification of Market Rule	6
Editorial Change	1
Market Rule Interpretation Request	2
Update to a Defined Term	3

Revisions to the Market Rules - Summary

- Revisions that were made in response to stakeholder comments were minor in nature. Examples include:
 - Increasing clarity of market suspension provisions in section 1.6
 - Modification to remove existing language that is no longer applicable (i.e. “integrated fashion”)
 - Modification to remove redundant language contained in Chapter 11 definitions (i.e. MMCP/MORP)
 - Editorial change to use “*administrative price*” rather than “*administrative pricing*”
 - Improving consistency of language between similar provisions as it relates to the application of the day-ahead market and real-time market
 - Various editorial changes to correct italics and punctuation
