These assets include the East Windsor Cogeneration Center, the Goreway Power Station, Kingsbridge 1 Wind, Port Dover and Nanticoke Wind, and the York Energy Center. Capital Power also has several projects in advanced development that have been awarded contracts through the IESO's recent competitive procurement processes, including the East Windsor Generation Facility Expansion, Goreway Battery Energy Storage System, Goreway Uprate, York Battery Energy Storage, and York Energy Center Upgrade projects. The Annual Planning Outlook and Annual Acquisition Reports provide an overall view of the grid and helps us better understand risks and opportunities associated with specific transmission regions, our assets, and potential new developments. Capital Power further references all data found within all the IESO's public and participant reports, including but not limited to the Adequacy, Transmission Rights, Capacity Auction, Generator Output and Capability, Hourly Ontario Energy Price, Intertie Flows, Market Demand, SBG Forecast, and Variable Generation Forecasts reports. Capital Power recommends that this data continue to be made available to market participants.</p> |
