On April 24 2014 the Ontario Power Authority received a [directive from the Minister of Energy](#) to develop and implement a new Stream 3 of the Industrial Electricity Incentive (IEI) Program.

Stream 3 of the IEI Program is for new and existing consumers in Ontario that will build a new eligible facility or expand their existing eligible facility, which is located in the Province of Ontario and is carrying on or will carry on an activity that is classified within specific NAICS Canada 2012 sectors.

This Stream of the IEI Program is now closed.
