1. Description of the events leading to Force Majeure Event.

Stem Energy Canada is unable to provide the contracted demand response capacity due to the effects of the Ontario government Declaration of Emergency which has mandated all non-essential businesses in Ontario to close. There are two customers who are serveing our Southwest Demand Response obligation, both of which are impacted by the Declaration of Emergency order. These locations have greatly reduced their operations, and as such there is no longer enough load to curtail to meet the obligation. We expect these locations to be impacted as long as the order is in place, which currently is in effect until May 19th.
