Consequential to MR-00394-R00 it is proposed to insert new defined terms in Chapter 11 of the market rules.

#### Background

#### Discussion

New defined terms are required in Chapter 11 of the market rules with respect to the introduction of section 3.2B of Chapter 5 as described in MR-00394-R00. The new defined terms are as follows:

- BES exception applicant
- BES exception request
- Bulk electric system exception or BES exception

In addition to the above defined terms and in order to permit BES applicant's access to the dispute resolution process it is necessary to modify the defined term "reviewable decision" to incorporate decisions made in regards to a BES exception request in section 3.2B of Chapter 5.

### PART 4 – PROPOSED AMENDMENT

## Chapter 11

*BES exception applicant means (i) a market participant who owns IESO controlled-grid elements or facilities who applies to the IESO for a BES exception; or (ii) a connection applicant who applies to the IESO for a BES exception;*

*BES exception request means an application for the approval, amendment, termination, or transfer of a BES exception pursuant to section 3.2B of Chapter 5;*

*bulk electric system exception or BES exception is an exception from compliance with the requirements of NERC reliability standards relating to elements or facilities connected to the IESO controlled-grid in accordance with the Ontario-*

adapted NERC procedure for processing BES exceptions;

*reviewable decision* means a decision of the IESO referred to in section 2.1.2, 4.4.3, 5.1.12, 5.3.9 or 6.1.5 of Chapter 6 and sections 3.2A.1, 3.2A.5.3, 3.2A.10, 3.2B.5.3, 3.2B.7 or 3.2B.10 of Chapter 5;

## **PART 5 – IESO BOARD DECISION RATIONALE**

This amendment inserts new definitions in Chapter 11 of the market rules consequential to MR-00394-R00 Bulk Electric System Exceptions.
