- 1) The information contained in this Application is true, accurate and complete in all material respects;
- 2) As of the date of the Application, I have met all the applicable Mandatory Eligibility Requirements and this Application meets all the applicable Mandatory Application Requirements.
- 3) As of the date of the Application, I am not aware of any delay, circumstance, event or cause that would adversely affect the viability of the Project or the Project Partnership in any material way;
- 4) I, the Proposed Project Partner, or its Affiliate, if applicable, have Access Rights to the Project Site required under the Mandatory Eligibility Requirements section of the Partnership Rules;
- 5) I am not in Default of any existing agreements with the IESO, its predecessor entities, or any of their third party fund managers, including funding agreements under the Support Programs, and I have not been in Default of any other agreements with the IESO, its predecessor entities, or any of their third party fund managers that have been terminated as a result of such Default;
- 6) I have not undertaken any communication prohibited by Section 8.1(c) of the Partnership Rules;
- 7) Other than as set out in the Application, I have not received, and do not expect to receive, any funding for any activities that are, or could be perceived to be, duplicative of funding requested under the Application and, in respect of any other actual or potential source of funding disclosed as part of this Application, I consent to the IESO contacting such sources of funding in accordance with Section 5.7 of the Partnership Rules.
- 8) All supporting documents required by the Rules have been attached to this Application;
- 9) I have complied with Section 9.3 of the Partnership Rules.
- 10) I acknowledge that this Application will not be processed or reviewed by the IESO unless it is complete, and, if found incomplete, may be rejected by the IESO;
- 11) I have read and I am submitting the Application in compliance with the Rules, and acknowledge and agree that the Application shall be subject to the Rules and that the Applicant shall be bound by the Rules in relation to the subject matter of this Application;
- 12) I consent, and I have sought and received the consent of the Project Partner and its Affiliate (as set out in the Application) for the IESO to (a) communicate with the Proposed Project Partner, its Affiliate or any other relevant third parties, and (b) use all information, including Confidential Information, in the possession of the IESO, for the purposes of evaluating and accepting or rejecting the Application;
- 13) I acknowledge that the IESO reserves the right to disclose all information contained in an Application, a Funding Agreement and all other information relating to an Applicant, the Proposed Project Partner and its Affiliate that it has received in the course of carrying out the EPP as provided for in Section 9.7 of the Partnership Rules.
- 14) I incorporate by reference the further representations, warranties and agreements set out in the Partnership Rules and hereby restate such representations, warranties and agreements for the benefit of the IESO.
