Hydro One welcomes the expanded scope of wording from the May 1, 2008 version of MR-00343 originally posted for comment, which now extends the recourse mechanism from market rules to market manuals.

However, Hydro One continues to encourage the IESO to define the terms that are used in the market rules, and we note that the terms that are added in the proposed market rule amendment, namely, “standard”, “policy” or “procedure” are not defined terms and this potentially creates confusion for market participants with respect to where their obligations reside.

In Hydro One’s opinion, all obligations on market participants created by the IESO should reside either in the market rules, or in the associated market manuals.
