	<p>Section 4.5.2.6 – Monthly Settlement:</p> <ul style="list-style-type: none">- Please clarify what kind of facilities that are withdrawing energy is exempt from the Global Adjustment Settlement Amount in Table 4-19. <p>Section 5.3 – Hydroelectric Contract Initiative (HCI):</p> <ul style="list-style-type: none">- Per the HCI contract, adjustments for errors can be issued up to one year following the end of the contract year in which such statements were issued. Please confirm if this timeline is also applicable to disputes. As the treatments of adjustment for errors and for disputes are covered separately, please clarify how the latter would be treated.- Per the HCI contract, the difference between errors (e.g., arithmetic errors) and disputes is not clearly stated. Please provide a definition and example of a dispute to help market participant distinguish it from errors.

Click or tap here to enter text.	<p>Section 2.2 – Final Settlement Statements:</p> <ul style="list-style-type: none">- We made suggestions on the formatting and presentation of settlement statements regarding retroactive adjustments, prompted by an adjustment of RT-GCG Cost Recovery Charges (cc183: RT-GCG Cost Recovery Charges - Historical Adjustment Period Allocation) in a series of emails in 2021. Our proposal aims to help market participants flag and verify potential retroactive adjustments ahead of time. We remain available to discuss our proposal with the IESO.

In the event where there is a delay and invoices are published later in the day, please allow market participants an extra day (i.e., 3 days rather than 2 days) to process payable invoices. <p>Section 4.1 – Reviewing Settlement Invoices:</p> <ul style="list-style-type: none"> - We ask that the IESO proactively communicate issues and errors—for example the Incorrect Tax calculation with RSS Go live—to market participants to help us prepare to take the appropriate settlement action.
