<p>Please provide feedback on any contract provisions you wish to comment on.</p> <p><i>Note: the commercial structure/ revenue model for the LT1 Contract will not be modified from that which was used under the E-LT1 Contract.</i></p>	<p>May 2027 COD will be a very tight deadline if project award is scheduled for Q2 2024. It is recommended that the IESO consider either using a blanket extension on COD timelines or consider including COD ranges for projects that are dependent on components with long lead times and/or dependent on the size of the projects.</p>

General Comments/Feedback

Deliverability Testing Schedule:

The IESO should consider providing deliverability test results earlier or delaying the proposal submission date. The current schedule does not provide adequate time between deliverability test results and proposal submission. Additionally, there is also concern about the time between when rated criteria is published and the deadline for deliverability testing. Locational/duration criteria will influence which projects are selected for deliverability testing.

SWEB understands that the timing to complete the deliverability testing will be dependent on the volume of project submission. As such, SWEB recommends that the IESO consider a high volume and therefore a longer timeline to complete the deliverability test and provide results.
