

Energy Efficiency Programs Progress Report

FIRST QUARTER 2019



Overview

This report highlights the recent achievements of Save on Energy and IESO delivered programs in the first quarter of 2019 (Q1 2019), as well as progress towards the 2015-2020 target established as part of the Conservation First Framework (CFF). Total preliminary Q1 2019 incremental energy-efficiency program savings results indicate 42 gigawatt-hours (GWh) and 7 megawatts (MW) of net reported 2020 annual energy and peak demand savings respectively.

Ontario's energy efficiency programs have achieved a total of 6,056 GWh (82%) of the 7.4 TWh 2015-2020 target as of Q1 2019. Under the Industrial Accelerator Program (IAP), 424 GWh (33%) of the 1.3 TWh 2020 IAP target has been achieved (in-service) as of Q1 2019, with a total of 815 GWh currently under contract.

All activity and savings results in this report are savings persisting to 2020 unless stated otherwise. Results are presented at the end-user level, are based on projects reported and invoiced to the IESO, are unverified and subject to evaluation, measurement and verification prior to be reported as final.

Any projects that have been completed, but not yet reported and invoiced to the IESO are excluded. Where a value of zero is shown, this indicates that no event, project, or activity associated with savings occurred the reported period. Note:

On March 21, 2019, the IESO received a directive from the Minister of Energy, Northern Development and Mines, terminating CFF. The IESO was further directed to begin delivering Energy Efficiency programs across the province under the Interim Framework. The Interim Framework is expected to run between April 1, 2019 and December 31, 2020 and has a draft target of 1.4 TWh in energy savings and 189 MW in demand savings. The framework offers programs to businesses, low-income customers through the Home Assistance Program, and continues to support energy-efficiency opportunities for Indigenous communities. This quarterly report will be the last reported results associated with the CFF / IAP. The IESO will continue to report against progress of the Interim Framework on a quarterly basis.

Portfolio Results

Table 1 summarizes results for Q1 2019 as well as to date, and progress towards respective targets. For the purposes of this report the IESO's portfolio includes programs delivered by LDCs, or the IESO, and IAP.
