Energy Efficiency Progress Report

SECOND AND THIRD QUARTER 2019







Overview

This report highlights the progress of the 2019-2020 Interim Framework delivered by the IESO for the period of April 1, 2019 through September 30, 2019. The tables below outline the reported energy and demand savings, the financial spending and participation for each program for this period, as well as progress against the 2019-2020 Interim Framework Program Plan.

The IESO will report on the progress of the Interim Framework (IF) on a quarterly basis. Also as part of its responsibilities, the IESO will publish results of its annual Evaluation, Measure and Verification (EM&V) related to the activities of the Interim Framework, including costs related to audits, capability building and training. All activity and savings results in this report are savings persisting to 2021, unless stated otherwise. Results are presented at the end-user level, are based on projects either committed (e.g. contracted) or actuals (e.g. invoiced to the IESO), are unverified and subject to evaluation, measurement and verification prior to reported as final.

As of Q3 2019, approximately 10% of the total IF budget has been committed through projects under contract and 13% of the energy savings and 17% of the demand target is committed. Over 7,000 homes and businesses have participated in Save on Energy programs as of Q3 2019.
