Enabling Resources Initiative: Overview

 Objective is to produce an integrated work plan outlining the sequencing, timing and scope of activities to be undertaken by the IESO over the next 5-10 years to enable existing resources to provide services that they cannot fully provide under current market design



Enabling Resources Initiative: Approach

- Activities may include pilots, programs or market enablement depending on which offers the most expedient/efficient path to unlocking resource value
- Work plan will seek to time completion of enablement initiatives to unlock resource potential to participate in Resource Adequacy procurements, as appropriate
- Hybrid Integration Design Project and DER Roadmap scoping work to begin shortly
