Note: This document is provided for informational purposes only and outlines the timelines and key milestones that must be completed by prospective capacity auction participants to participate in the IESO's capacity auction. This version of the document reflects milestones associated with the introduction of a capacity qualification process, updates to the performance assessment framework and demand curve, and administrative changes that are expected to take effect for the 2023 capacity auction, pending the outcome of the market rule and manual approval process. As the information provided in this document is subject to change, the Pre-Auction Report and any revised and updated version of this document will prevail in case of any inconsistency with this document. Those who intend to participate in the CA are responsible for complying with all requirements under the Market Rules, Market Manuals (including Market Manual 12: Capacity Auctions), and relevant policies, standards and procedures.
