Refer to the 'New Demand Response (DR) Resources' section in the Forward Period table. Participants should refer to MM1.5 for other important deadlines regarding registering a new demand response resource.

<sup>&</sup>lt;sup>6</sup> Energy Trader Authorization includes posting physical market prudential support per Chapter 2 Section 5 of the Renewed Market Rules. Participants with a capacity import resource should complete the CMP authorization process after first becoming authorized as an Energy Trader. In these scenarios where both authorizations must be completed, CMP authorization must be completed before the first day of the obligation period.
