Implementation Phase





Principles for Tools, Testing, and Training

- Leverage current platforms as much as possible to minimize impact on participants
- Use stakeholder insights to consider the impact of a change, and provide time to manage the change
- Continue using the Market Renewal principles to guide this phase of activities



Market Participant Impacts

- Most changes fall upon dispatchable participants
- When reviewing Detailed design documentation:
 - Section 5 highlighted changes to market facing procedures
 - Section 6 described areas of change to external business processes and information flows
 - Appendix A highlighted tools changing through Market Renewal
- Broader education efforts across the sector, including non-participants
- Confirmation of participant readiness



What's Changing in the Renewed Market?

- 1. Market Participant Business Processes: Data collection and submission
- 2. New Participation Types: Virtual Transactions and Price-Responsive Loads
- 3. Tools: Energy Management Interface; Dispatch Workstation; Online IESO;
- 4. Reports: New data and reporting
- 5. Settlements: New charge types; Same format



Market Participant Business Processes

- Participants are already collecting information, and reviewing documentation
 - Reference Levels, new Hydroelectric parameters, Pseudo-Unit modelling
- New participation opportunities
- Offer strategy



New Participation Types

- New participation types with Virtual Transactions and Price-Responsive Loads; will require information to registered earlier to be ready for go-live
 - Pseudo Unit model will also require a change in registration information
- Full detail on registration requirements will be available for training early in 2023



Tools and IT Changes

- Functional changes to Energy Management Interface, and Dispatch Service will require testing, market trials from all dispatchable participants
- Online IESO and Settlement changes are accommodating additional data into existing processes



Reports

- Significant changes to reports and publishing new data as a result of the renewed market
- Using XML format, and will have schema files available for review
- Training, schemas, and sample files available throughout 2022, with reports available in the Sandbox throughout 2023




Settlement

- Settlement: New Charge Types; Same Format of Statements and Invoices
- Expanded processes for disagreements and expanded Notice of Disagreement (NOD) window
 - Changes within Online IESO workflow
- Timing for Charge Types and Equations documentation: Q4 2022
- Market Participant testing for modifications related to NOD process
 and recalculated settlement statements in 2022
