LT1 RFP Design and Key Updates

Please provide any general feedback on the LT1 RFP design and the key updates provided by IESO in the meeting.	Rated Criteria – Municipal Support The IESO introduced on Aug.10 th the rated criteria points for the Municipal Support to be either max 6 points if Municipal Council Support Resolution is reached, or 0 points if not reached. No points to be awarded for evidence of the progress made. Given the upcoming municipal Fall elections and the new elected municipal council return to business activities coinciding with the Expedited Process RFP deadline, having newly elected council meet to vote for the resolution to align with the IESO expedited timeline could be challenging for proponents. Furthermore, pushing the present municipal councillors to support these projects could cause interference with the election activities. Aypa recommends a more reasonable rated criteria scale to recognize the progress being made towards Municipal Support, whereby points are awarded based on achieving critical milestones such as: projects presented to the municipal council, initial feedback received from the municipal council, voting date confirmed, etc.

Please provide any feedback on the proposed design and other considerations with respect to the Same Technology Upgrades procurement process.	Moving the Same Technology Expansions form the Same Tech to Expedited procurement
	The IESO announced on Aug.10 th a change to move the Same Technology Expansions (new separately metered, registered, and operated generation units) from the Same Tech Procurement to the Expedited Process. This change will considerably erode the potential for awarding and building energy storage resources in Ontario under the Expedited process.
	Aypa recommends that the total MW target of the LT1 RFP procurement is rebalanced and that the Expedited Process procurement target is considerably increased due to this change. We encourage the IESO to give a clear indication to the development community on the total MW's IESO expects to be procured and the storage allocation.
