## **Overview of External Readiness Assessment Surveys**

- The MRP External Readiness team will conduct an assessment of market participant readiness from 2023-2025 through a series of surveys
- Objective: mitigate the risk of market participants being unprepared for changes to technology and market operations at Go-Live
- Benefits: highlight potential issues earlier allowing the IESO to coursecorrect readiness efforts



Assessment 2 had 177 Market Participants responding to the survey




# Survey Submission Rates

  - Organizations that are registered as more than one participation type are counted in more than one of the segments shown




## Question 1: Impact of MRP

# Question 2A – Why do you feel that way? (written)

'Slightly Behind' and 'Significantly Behind' Schedule

- Not done all tasks yet (i.e. reference levels, connectivity testing)
- Too busy with current work to review MRP
- Will be better able to judge progress once MPs are able to test solutions with sample and market participant specific settlement statements and reports
- Need remaining test cases and report specifications to proceed with some work (note: these are now available)
- Need more info needed on MRP, and need IESO help with connectivity issues



## Question 8: Updates to MP's Internal IT Systems

Q8: How are you progressing on your IT systems upgrades (1/2 of all MPs)?

Progress on Re- programming:	On Track	Progressing, but behind schedule	Don't Know
Reports APIs	67%	20%	13%
Internal Systems for Reports	63%	26%	11%
Settlement APIs	50%	29%	21%
Internal Systems For Settlements	58%	32%	11%
MIM/Dispatch APIs	78%	22%	0%
LDC Billing System	50%	33%	17%

# Question 11: MRP Information/Assistance

Has your team received info/assistance it needs for MRP?

- 77% of all respondents said 'Yes'
  - Higher End (85%+): LDCs, Transmitters
  - Mid Range (75-80%): Energy Traders, Virtual Traders, Loads
  - Lower End (70-75%): Generators, Storage, Capacity, Financial Market
- 'No' responses were also asked "how else can IESO help"?



# Question 11A: 'How can IESO help'? (written)

- More help with MRP testing issues
- More info on specific impacts by MP segment, not general info
- Need more information on when MRP training will be available
- Topics: how DAM works, standing offers, RT pricing for nondispatchable generators, list of IT changes (IESO Note: some of this information is already posted on MRP webpages)

- MRP Business Advisors will be reviewing survey responses and reaching out with more information/assistance, where applicable
- Targeted efforts to involve remaining inactive MPs into MRP, and to complete Market Trials and preparation work this summer/fall
