MRP Implementation Working Group Meeting Summary January 22, 2025

Agenda Item 1: Welcome; Agenda and Standing Item Review (with materials)

- A number of issues reported in the update memo are now closed with the exception of the item for the IESO to provide Market Participants an overview of the type of communication that they will receive during the Market Renewal Launch which will be closed after this meeting.
- A group of gas generators applied to the Ontario Energy Board (OEB) for a review of the MRP market rule amendments. A hearing with the OEB and intervenors occurred last week. The OEB will render a decision by March 6, 2025.
- End-to-End Testing started on Monday January 20, 2025.
- **Q:** During End-to-End Testing, it was observed that traffic in the Sandbox environment for IESO Report site is slower than normal. Will this be fixed before MRP Go-Live?
 - **A:** Please report this to the IESO and provide details such as if this is an intermittent issue and/or if it is occurring during specific hours. The MRP IT team will further investigate this issue.
- **Q:** The IESO communicated to Market Participants that the *Predispatch Intertie Transactions Schedule and GOG Eligible Extensions Report* has been paused. Will the IESO be publishing historical reports as it has been communicated that the IESO will only be publishing future reports?
 - **A:** It may be possible to reproduce past reports . The IESO is currently looking into this and will communicate shortly.

Agenda Item 2: Communications related to MRP Launch (with materials)

- The IESO went through the presentation material that outlines the communications channels that will be used related to MRP Launch.
- **Q:** Does the Go or No-Go Decision on MRP Go-Live come from the IESO Board? Does the decision require input from the Provincial Government?
 - **A:** The decision is made by the IESO's CEO. The IESO updates the Provincial Government on MRP however the implementation of this program is not dependent on a decision from the Provincial government as it is part of the IESO's mandate.
