#### Overview

- The cutover test involving Market Participants is scheduled from March 31, 2025 until April 2, 2025.
- Market Participants will need access to the following systems to be able to participate in this test:
  - New Energy Market Interface (EMI) in the **Pre-Production** environment
  - New Market Information Management (MIM) system in the Pre-Production environment
  - Legacy Energy Market Interface (EMI) in the Sandbox environment
  - Legacy Market Information Management (MIM) system in the Sandbox environment
  - New Dispatch Service user interface in the Pre-Production environment
  - New Dispatch Service system in the Pre-Production environment
  - IESO Reports Site in the Sandbox environment
- The times that are listed on this deck are estimates and are in EST. The duration and/or start of specific steps may be delayed if unexpected delays occur during the cutover exercise.

#### Overview (cont.)

• The descriptions of each step are provided in Table 3-1 of the MRP Readiness Plan for Market Renewal Launch. The cutover testing activities that occur on the following dates coincide with the dates that are specified in the MRP Readiness Plan for Market Renewal Launch:

Date in Cutover Test	Date in MRP Readiness Plan for Market Renewal Launch

April 1, 2025	May 1, 2025
April 2, 2025	May 2, 2025

- Not all activities in the <u>MRP Readiness Plan for Market Renewal Launch</u> will be executed during the cutover test. The test will end on the activity scheduled for May 2, 2025 04:00 EST (05:00 EPT) when the IESO announces that the market transition is complete.
- The <u>MRP Readiness Plan for Market Renewal Launch</u> may be updated based on the outcomes of this cutover test.

#### Overview (cont.)

- Market Participants will not be using gTest for this exercise.
  - During the cutover test, participants can report issues they encounter and/or ask general questions through the IESO Customer Relations mailbox: <a href="mailbox:customer.relations@ieso.ca">customer.relations@ieso.ca</a>.

- When reporting issues to the IESO, participants should use the following prefix in the subject line,
   "MRP Cutover Test".



#### Out of Scope Items and Activities

The cutover test will not include the following for Market Participants:

- the cutover sequence for the day-ahead market (DAM),
- rollback sequence to the real-time market (RTM),
- posting of notifications on the Advisory Notices page,
- manual dispatches and administrative pricing
- verifying changes to the Outage Coordination and Scheduling System (OCSS),
- verifying changes to Market Participant Prudential System,
- verifying changes to settlement statement and data files,
- verifying changes to the IESO public website,
- verifying their ability to register as a virtual trader,



#### Out of Scope Items and Activities (cont.)

- verifying their ability to be authorized as a price responsive load (PRL) in the renewed market, and
- some reports may be scheduled outside this window and will not be published during the cutover exercise.
