1. Introduction

This document provides an overview of **Test Scenario 4: Notice of Disagreements (NODs)** under the End-to-End Testing phase of the Market Renewal Program.

This document includes the following information:

- a short description of the test scenario as it relates to Market Rules Chapter 0.9 s.6.8 and Market Manual Part 0.5.10 s.3,
- out of scope items and activities during this test execution,
- the resource and participation types that are recommended to execute this test scenario,
- key dates for impacted Market Participants, and
- the test cases along with the steps that users will execute to verify this test scenario.

2. Scenario Description

Market Participants may test the ability to submit Notices of Disagreement and receive automatic confirmations from the IESO after the submission. The IESO will not be assessing the submitted NODs for this test phase. As a reminder, the NODs may only be submitted during the NOD window of 6 business days after the statements are issued.

The market participants will verify the test by ensuring that they received an automatic confirmation after the NOD submission.

3. What is out of scope for this test scenario?

The following items are out scope in the execution of this test scenario:

4. Impacted Participation Types

This test scenario is recommended for the following participation types:

- Dispatchable and Non-Dispatchable Generators,
- Dispatchable and Non-Dispatchable Loads,

- Dispatchable Electricity Storage Participants as a Load and as a Generator,
- Intertie Traders,
- Virtual Traders,
- · Price Responsive Loads (PRLs) and,
- Local Distribution Companies (LDCs).

5. Key Dates for Market Participants

This scenario will be simulated under Week 1 - Week 6 for Normal, High and Low demand profile of the End-to-End Testing Phase:

• This scenario will be simulated anywhere between **January 20**, **2025** to **February 27**, **2025**.

6. Test Case(s) under Test Scenario 4

Prerequisites:

- 1. Valid login credentials for Online IESO, IESO Confidential Reports site.
- 2. Testing User for that MP needs to have Notice of Disagreement Contact role assigned in Online IESO Sandbox.
- 3. MP must submit the NOD within six business days after the IESO issued the settlement statement.
 - Note: MP may submit the NOD only during the NOD window of 6 business days. During End-to-End testing MPs can perform functional testing for NODs (see End to End Settlement Schedule for dates) and the IESO will not be providing any resolution to these NODs.
- 4. MP must have participated in the market and triggered a PSS to be able to submit a NOD.

1	Login to the Online IESO Sandbox application with the correct credentials.	User Login is Successful.
2	Using the Actions menu, select-> Submit a Settlement Disagreement, and then specify a trade date.	The NOD form submission window opens up.
3	Select the Disagreement Channel and fill out all the forms, Organization Selection form Statement Selection form Line Items Selection form Missing Line Items form Additional Information form	All MRP Charge Types listed on the Settlement Statement for this NOD are available for selection in the form and all of the required forms are filled out.
4	Select the Submit button, to submit the 'Notice of Disagreement' to the IESO.	Submission is successful.

Test Step #	Test Step Description	Test Step Expected Result
5	Check for IESO's acknowledgment of receipt.	Acknowledgement receipt will include: a unique identifier for the submission, and a date and time stamp of when the Notice of Disagreement was received.
