As a brief background, the Medium-Term 2 Request for Proposals (MT2 RFP) aims to procure existing resources with contracts expiring between 2026 and 2029. These resources are well-positioned to cost-effectively meet Ontario's emerging energy and capacity needs in the late 2020s and into the early 2030s. The MT2 RFP includes both capacity and energy streams, and proposals will be evaluated primarily on price. Registration is expected to open in September 2024, with the final RFP and contract expected in November 2024.
