Are there any areas of the draft MT2 RFPs that require further clarity?	<p>Suggest making an explicit statement that registration of a facility does not commit the proponent to submitting a final proposal</p> <p>Suggest adding clarification of process or evaluation criteria if suppliers choose to submit a proponent that does not meet the current eligibility requirement per Section 2.1 (a) (ii) (A) (ex. the current contract term ends AFTER the cutoff date of April 30, 2029), but wish to terminate their existing contract early, in favor of the MT2 contract (aka. how will this proponent be evaluated under these circumstances (Section 4.2 (a)?)</p>

Are there any areas of the draft MT2 Contracts that require further clarity?	MT2(e) contract – Section 2.1 (b) “For certainty, the Parties acknowledge that the Buyer is not purchasing from the Supplier, nor is the Supplier selling to the Buyer, any Electricity or Related Products hereunder” – this statement needs to be corrected

Do you have any feedback regarding the timelines and/or milestones proposed for the MT2 RFPs?	<p>October 18, 2024 - The IESO’s deadline to inform proponents of their Maximum Annual Average Imputed Production Factor is late. Please consider moving this date forward as this value is required for the economic bid statement. In order to gain approval on the proposal submission, several internal approvals are required well in advance of the submission deadline.</p> <p>December 23, 2024 – The IESO’s deadline for issuing Addenda is too close to the proposal submission deadline and the holidays where most people are out of office. If there is a big change, this could impact the proposal and would not allow enough time to evaluate.</p>
